Are you aware of the range and role of services working to support and safeguard both those at risk of exploitation and survivors?


How do you act upon issues or concerns in your communities?

Why it matters

Working Together to Safeguarding Children (2018) legislation discusses the importance of working together to identify and respond to harm and abuse posed to children outside of their home.

Safeguarding is everyone's responsibility; therefore, practitioners need to engage with individuals and sectors who do have influence over/within extra-familial contexts and recognise that assessment of and intervention with these spaces are a critical part of safeguarding practices.





Contextual Safeguarding is an approach to understanding, and responding to, young people's experiences of significant harm beyond their families.

These extra-familial threats might arise at a variety of places including community spaces and online.

This Contextual Safeguarding strategy will be inclusive of:

- Child Sexual Exploitation
- Child Criminal Exploitation
- Child Trafficking / Modern Slavery
- Missing From Home

priorities, this strategy
describes how agencies
will work together to

address any concerns within a trauma informed and strength-based approach

Priority 1:

Increase our awareness and understanding of Contextual Safeguarding.
